

**TERMS AND CONDITIONS FOR "ASSISTANCE FOR PRODUCTION OF MATTRESS EXCLUDING CARRY BAG AS PER PROV SPEC. No. S/6252/C/MATTRESS ECC/TC-6**

1. Essence of this contract is to fabricate Mattress **inside** OEFC premises and supply Mattress as per prov.  
Specification No. S/6252/C/MATTRESS ECC/TC-6; **excluding** carry bag.
2. The firm has to quote their rates in terms of Rupee **per** no. of Mattress. Price bid evaluation will be done on this basis only.
3. The participating firm has to install their own plant & machinery to be used in fabrication; inside premises of OEF, Kanpur:-
  - i) Hydraulic thermal press as per size of Mattress - 02 nos.
  - ii) Heat sealing machine for fixing of valve - 02 no
  - iii) Cutting machines for cutting of fabric and Foam - 02 nos.
4. Also the firm has to supply input materials required for manufacturing of Mattress against this contract:
  - i) PU coated Polyester Fabric OG – As per Appendix 'A' attached to specification.
  - ii) Polyurethane Foam – As per Appendix 'B' attached to specification.
  - iii) Valve Brass with Plastic Top – As per drawing attached to this specification.
  - iv) Hook & Loop Strip – IS:8156
  - v) Buckle Plastic – Best Trade Quality.
  - vi) Polythene Bag – CQA (GS)/SS/540.
5. The firm has to install all the required P&M inside OEFC premises; as mentioned above within 25 days after placement of supply order. Otherwise supply order is liable to be cancelled at the discretion of the Competent Authority. Cost of transportation, Installation (including civil works; if any) and maintenance of above mentioned P&M will be borne by the firm. The firm has to submit an affidavit duly notarized stating that in absence of installation of machines within stipulated period, supply order will be cancelled at the discretion of the competent authority in addition to the debarring of the firm.
6. The firm should complete the production as per plan envisage delivery period in staggering mode. The firm shall deploy its essential manpower on the installed P&M for fabrication of Mattress.
7. Working space and electricity connection will be provided by OEFC to the firm. Electricity charges will be borne by the firm on actual consumption basis.
8. The firm shall bring all the input materials to be used inside OEFC premises and will offer a challan against each lot for inspection/testing of the input materials, before commencing the bulk production. The firm shall start production only after receipt of acceptance of input materials from OEFC. The firm will also submit test reports from NABL accredited laboratory for all the input materials being used in the fabrication.
9. After production, Mattress ECC will be subjected to testing and inspection as per specification. Rejection, if any on account of failing in test parameters, poor workmanship and visual inspection will



10. OEFC team may draw random samples of input materials being used from the production line. The samples will be drawn in the presence of Firm's authorized representative. The samples drawn will be subjected to testing of parameters as per specification and in case of any deviation found; penal action as deemed fit will be initiated against the firm including cancellation of contract.
11. Safety, security of the material and men and conduct of men deployed in the job will be sole responsibility of the firm and submit an undertaking to this effect. However all necessary assistance will be provided by OEFC. The PVR of the deployed Men should be completed.
12. **Inspection:**  
After offering fabricated Mattress by the firm, inspection will be done by the General Manager or his Authorized Representative. Thereafter the procedure in vogue will be enforced for inspection of final product.
13. **Packing :**  
The firm will supply Mattress in flattened and rolled form, properly secured with two strips with buckles as per specification. Such rolled Mattresses will be packed in suitable size of polythene bag.
14. **Guarantee/Warranty:-**  
12 Months from the date of supply, as per standard warranty clause.
15. **Eligibility Criteria:**
  - i) Physical capacity of the firm will be verified by a team deputed by OEFC to ascertain capacity and capability of manufacturing of Mattress ECC as per specification, at the bidder's OEM location.
  - ii) The firm should have Hydraulic Thermal Press as per size of the Mattress ECC (02 nos.), Heat Sealing Machine suitable for fixing of valve in the Mattress (02 nos.) and Cutting Machines for fabric and foam (02 no.).
  - iii) Firm should submit proof of Ownership of above machines during Physical Capacity Verification. Proof of Ownership document must be dated on or before the date of tender opening.
  - iv) The firm has to demonstrate manufacturing of the tendered item as per specification no. S/6252/C/MATTRESS ECC/TC-6 during physical capacity verification conducted by OEFC.
  - v) Physical Capacity Verification will be done immediately after tender opening. The participating firm should be ready for Physical capacity immediately.
  - vi) Physical Capacity Verification will not be carried out of the firms who are already registered for Mattress ECC/Mattress ECC Excluding Carry Bag. However, firm has to submit proof of Ownership of above requisite Plant & Machineries.
